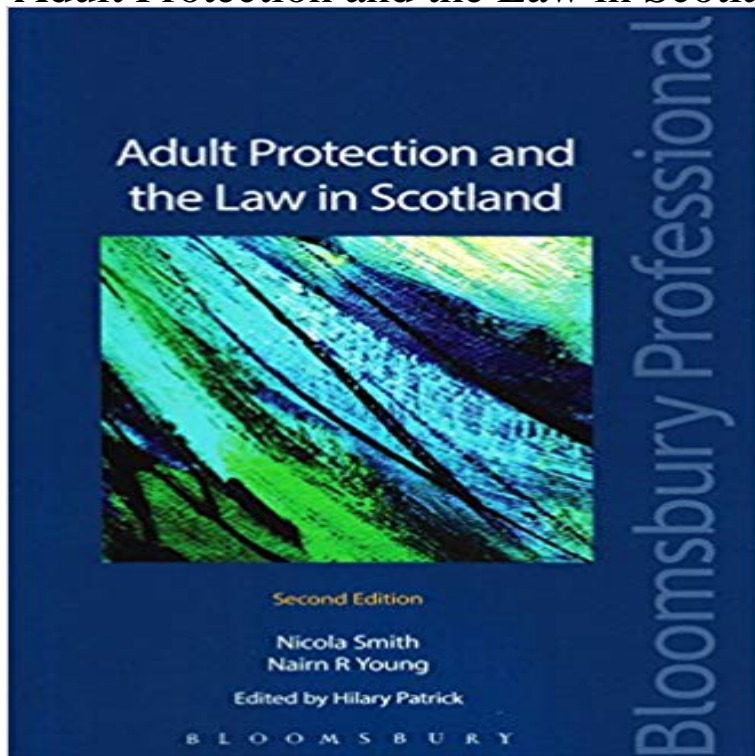


Adult Protection and the Law in Scotland: Second Edition
