


On a Wing and a Prayer: Interviews with Airline Disaster Survivors



I told myself, Don't panic! You can get out! ... I believed that my positive thinking helped me to survive. I did not panic. I did not want to die, and I intended to do everything necessary to prevent it. I decided that if I was going to die, then it was God's will. Flight crews, mothers, business travelers, and others reveal in these detailed interviews what they thought, felt, and did -- from their first awareness of danger to preparing for impact, to their struggle to escape and help others to survive. Their incredible recollections of those harrowing moments are interspersed in synchronized time with excerpts from cockpit voice recorders that chronicle the cockpit crews' valiant efforts to bring the aircraft home safely.
