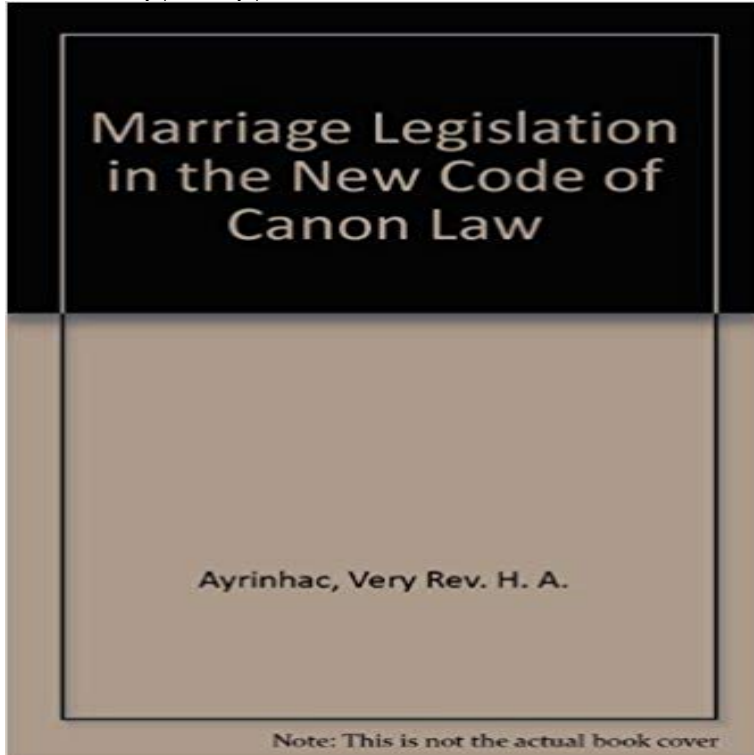


# Marriage legislation in the new Code of canon law
