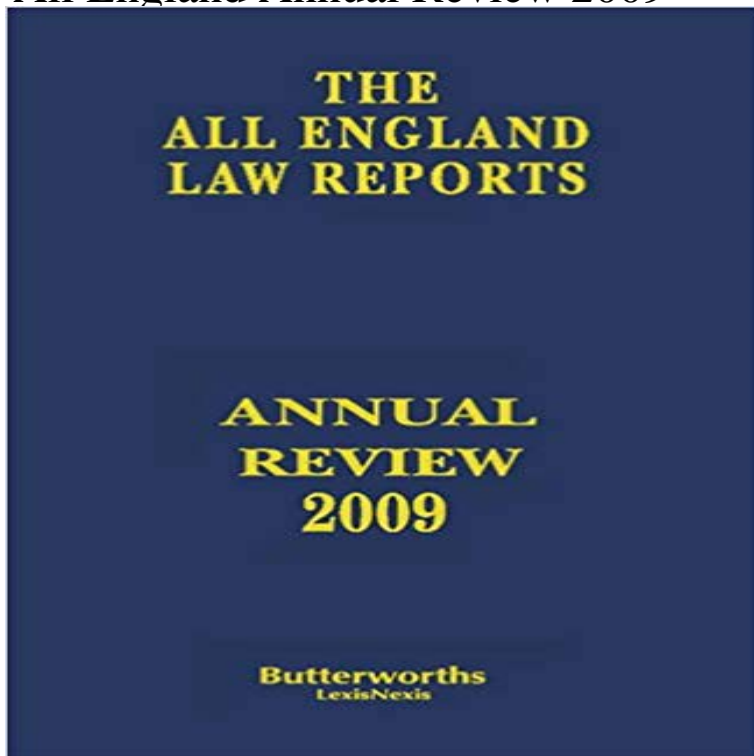


# All England Annual Review 2009
