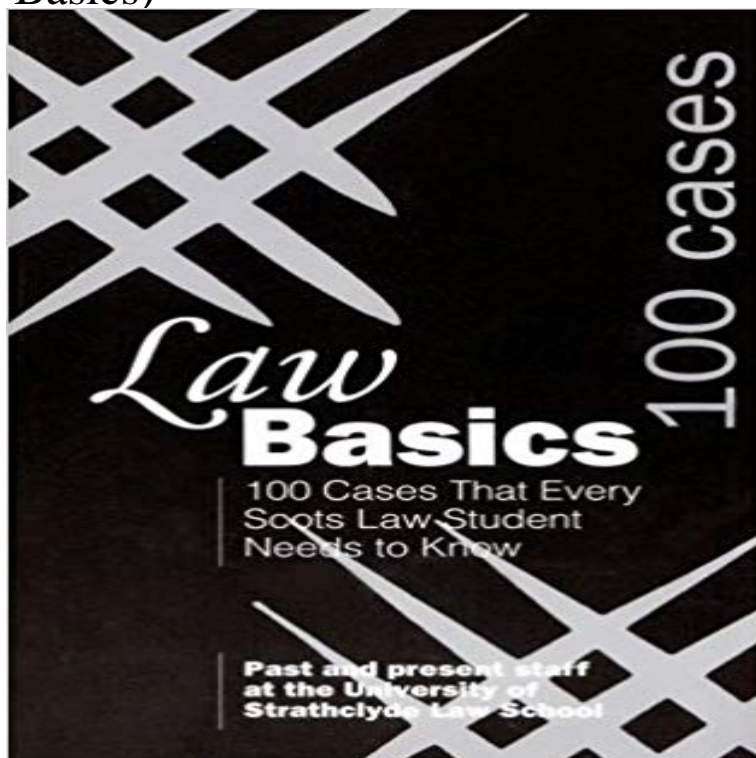


# 100 Cases That Every Scots Law Student Needs to Know (Greens Law Basics)
