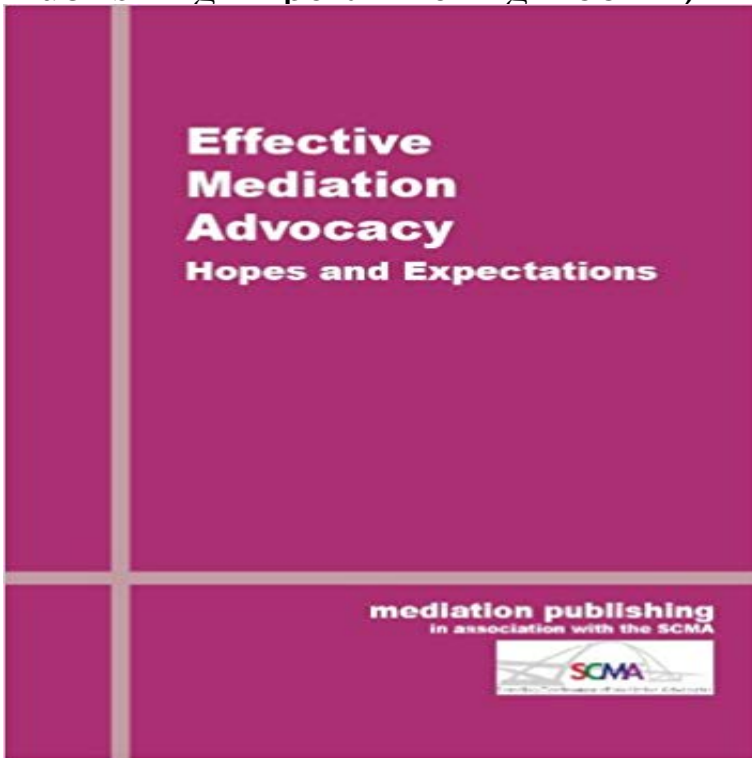


Effective Mediation Advocacy - Hopes and Expectations (Mediation Publishing Expert Briefing Book 1)
