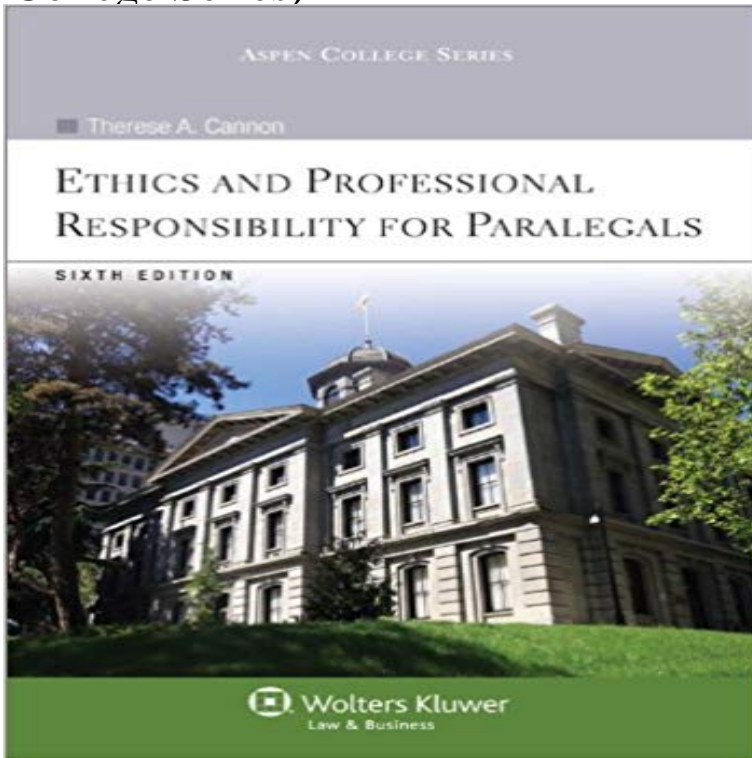


# Ethics & Professional Responsibility for Paralegals, 6th Edition (Aspen College Series)
