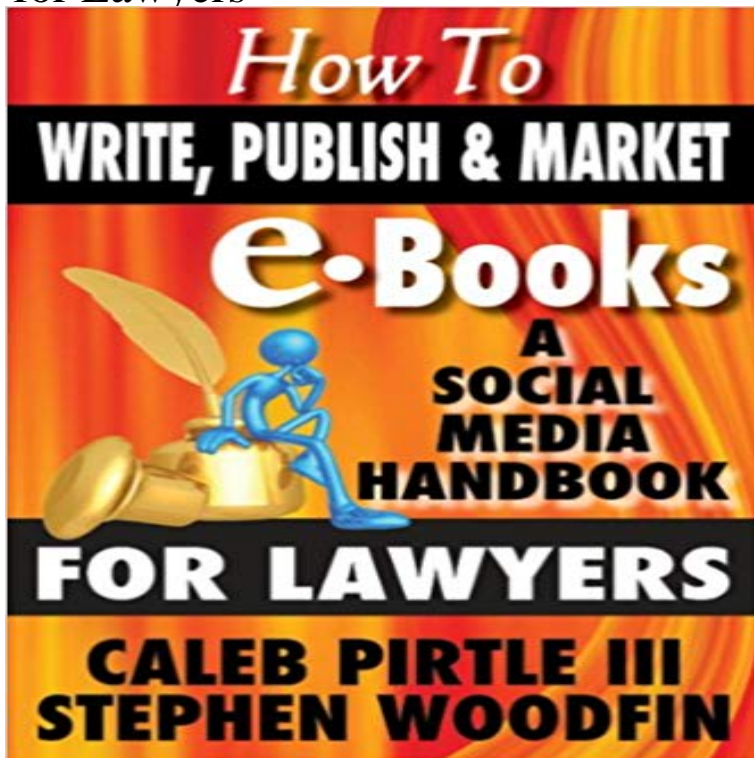


How to Write, Publish and Market E-Books: A Social Media Handbook for Lawyers
