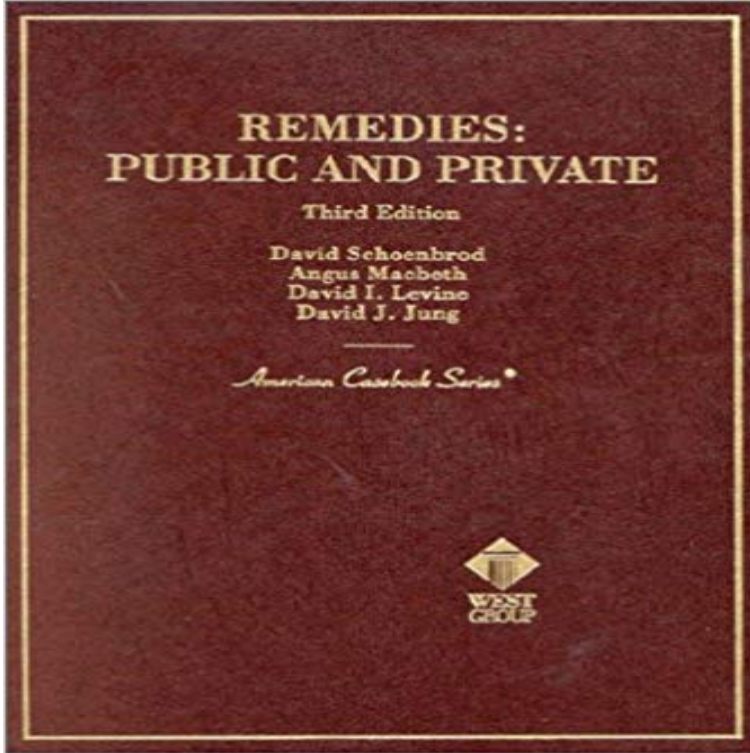


## Remedies: Public and Private (American Casebook Series)
