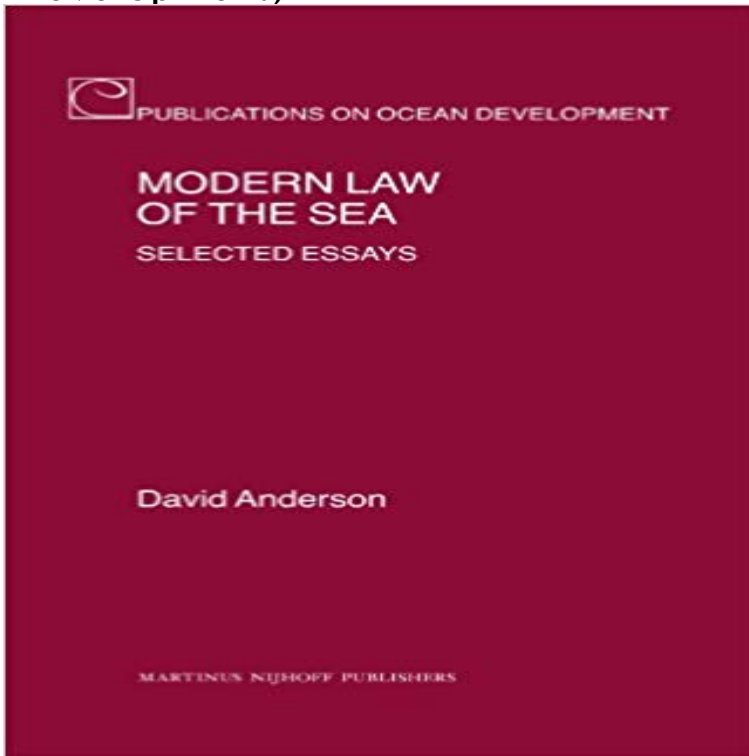


Modern Law of the Sea: Selected Essays (Publications on Ocean Development)

The essays, written between 1988 and 2006, will be of interest to everyone involved in the law of the sea.
