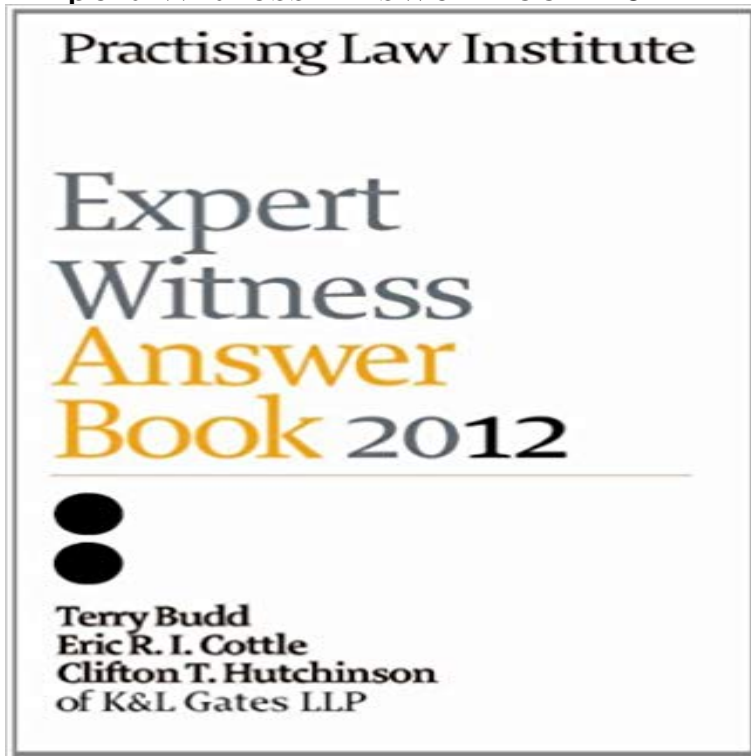


## Expert Witness Answer Book 2012
