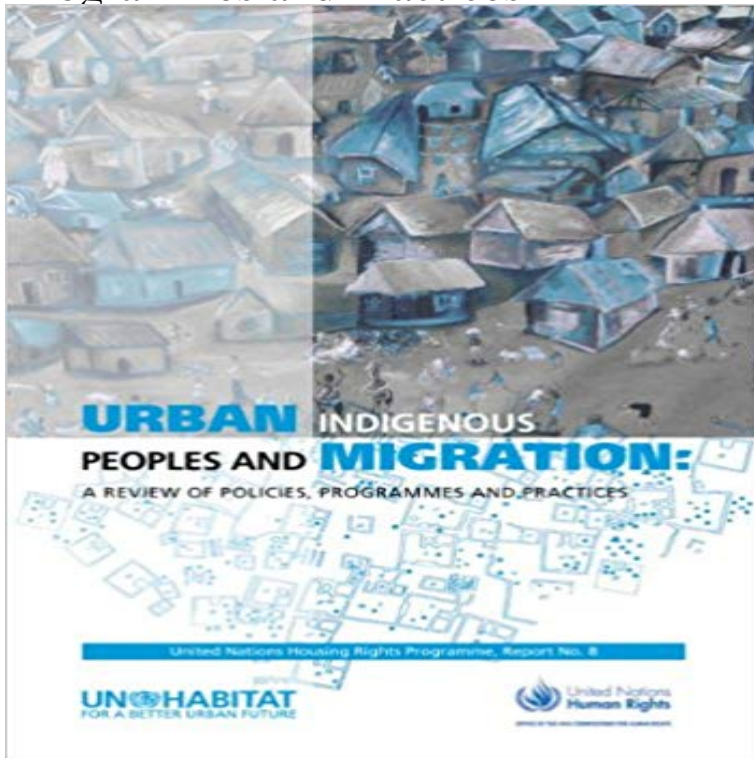


Urban Indigenous Peoples and Migration; A Review of Policies, Programmes and Practices
