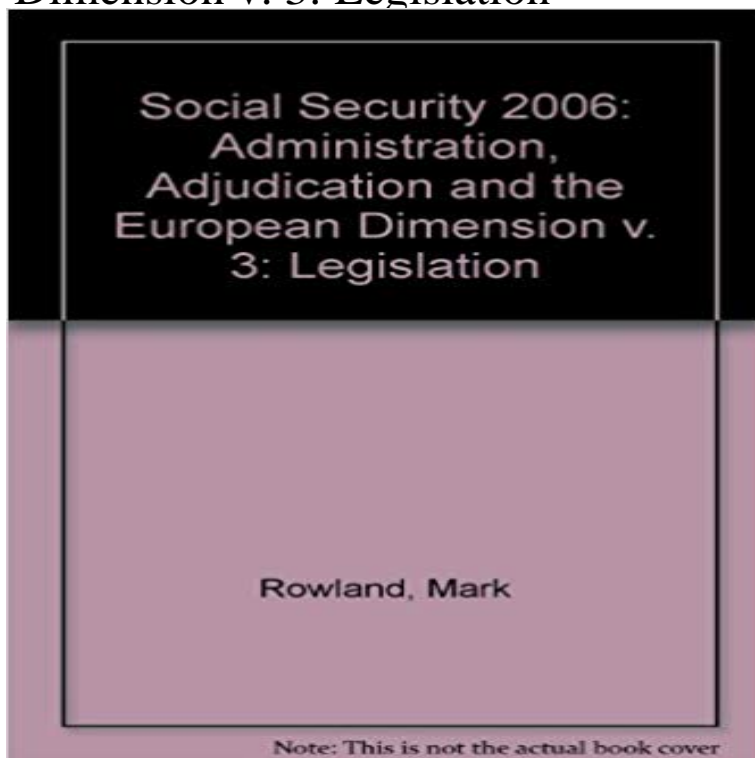


Social Security 2006: Administration, Adjudication and the European Dimension v. 3: Legislation
